#### Board Comment:

Mr. Panas had questions about the charter's advisory board and its authority. Mr. Cheye Calvo, Chief Growth and Community Engagement Officer, provided information for clarification. Mr. Panas had additional questions about the school's demographics. Ms. Gil responded with information about 7% of students in the Bay Area schools being African American and Latino. Mr. Panas continued with additional questions to which Rocketship staff responded. Assistant Principal Aisha Ford spoke about suspensions and discipline policies. Melanie Stager, Director of Finance, spoke about LCFF and LCAP budgeting.

Ms. Kronenberg asked for a sense of the spirit of the organization, in particular the quality of empathy. She asked if the school would be willing to sign an MOU that would relieve the financial costs the school would bring to the District. Ms. Gil spoke about values for working families struggling in the economic environment. Ms. Kronenberg said she would follow up with other questions offline.

Ms. Cuevas asked about unionizing of teachers if the petition is authorized. Ms. Gil responded about openness to opportunity and the organizations core values.

Mr. Phillips had questions about the number of parents in attendance from San Pablo supporting Rocketship. Rocketship staff unable to respond to the inquiry.

President Block spoke about the community's fear of Lake School closure if the charter school located in San Pablo. Ms. Gil provided clarification regarding a parent group of 500 parents expressing interest in locating a school in the San Pablo community. President Block continued with remarks about the community in attendance at the meeting and the intersection that opposes. President Block addressed about the evaluation process. Ms. Gil continued with remarks about communication of the process for the timeline in approving the petition in hopes to be completed by the end of the 2017 year, and concern for fair evaluation with inclusion of parent voice. Ms. Rashidchi said a suggestion was made to hold the petition to the January 17, 2018 meeting date as the petition is for the 2019-2020 school year as a reasonable time.

Mr. Panas had additional questions about the agenda for the January 17 meeting and whether there was any benefit to waiting. Ms. Rashidchi spoke about due diligence of staff in review of the petition.

Superintendent Duffy responded with there is an aggressive plan in place for next year. President Block responded about including a principal group as part of the implementation plan.

President Block asked Mr. Phillips if he would like to make a motion on this and he stated he did not since the votes were not there.
